6 LATE BIDS

6.1 Bids received late shall not be considered. A bid will be considered late if it arrived even one second after 11:00 or any time thereafter. The tender (bid) box shall be closed at exactly 11:00 and bids arriving late will not be considered under any circumstances. Bids received late shall be returned unopened to the bidder. Bidders are therefore strongly advised to ensure that bids be despatched allowing enough time for any unforeseen events that may delay the delivery of the bid.

6.2 The official Telkom time, which can be observed by dialling 1026 from any phone, will be used to verify the exact closing time.

6.3 Bids sent to the NEMISA via normal post or any other mechanism shall be deemed to be received at the date and time of arrival at the NEMISA premises (tender/bid box or reception). Bids received at the physical address after the closing date and time of the bid, shall therefore be deemed to be received late.

7 PAYMENTS

7.1 NEMISA will pay the Contractor the fees set out in the final contract according to the table of deliverables. No additional amounts will be payable by the NEMISA to the Contractor.

7.1.1 The Contractor shall from time to time during the duration of the contract, invoice NEMISA for the services rendered.

7.1.2 The invoice must be accompanied by supporting source document(s) containing detailed information, as NEMISA may reasonably require, for the purposes of establishing the specific nature, extent and quality of the services which were undertaken by the Contractor.

7.1.3 No payment will be made to the Contractor unless an original tax invoice complying with section 20 of the VAT Act No 89 of 1991, as amended, has been submitted to NEMISA.

7.1.4 Payment shall be made by bank transfer into the Contractor's back account normally 30 days after receipt of an acceptable, original, valid tax invoice. Money will only be transferred into a South African bank account. (Banking details must be submitted as soon as the bid is awarded).

7.2 The Contractor shall be responsible for accounting to the appropriate authorities for its income tax, VAT or other moneys required to be paid in terms of the applicable law.

TERMS OF REFERENCE (TOR)

PROVISION OF COMPREHENSIVE SHORT - TERM INSURANCE – 3 YEAR CONTRACT

1. BACKGROUND:

NEMISA is a Schedule 3A Public entity in terms of the Public Finance Management Act no. 1 of 1999. NEMISA is positioned as a national catalytic collaborator, leader, policy developer and strategic impact assessor in aligning e-skills interventions with the National Development Plan 2030.

NEMISA business operations are dependent on having optimal short-term insurance cover in the event the organisation suffers a loss. This insurance should cover all NEMISA assets, including vehicles and properties, business interruption, public liability, SASRIA, international travel and contractors “All risk”, cash in transit and assets amongst others.

The purpose of this Tender/Bid is to procure the services of a competent insurance broker to assist NEMISA in managing its short-term insurance portfolio. The service provider appointed would need to ensure that cover and premiums are negotiated in the best interest of NEMISA, as and when required.

2. DURATION OF CONTRACT:

The contract period is for 36 months (3 years) from the appointment date.

- **Date subject to change**

All times and dates in this bid are South African Standard Time. Any time or date in this bid is subject to change at NEMISA sole discretion. The establishment of a time or date in this bid does not create an obligation on the part of NEMISA to take any action or create any right in any way for any bidder to demand that any action be taken on the date established. The bidders accept that, if NEMISA extends the deadline (the closing date) for bid submissions for any reason, the requirements of this bid otherwise apply equally to the extended deadline.

3. DELIVERABLES:

3.1 Administration

- 3.1.1. The Service Provider will be required to obtain short-term insurance cover from the insurance industry based on the needs of NEMISA, the prevailing market conditions at the time and the insurance products that are available to mitigate or partly mitigate the risks as identified.
- 3.1.2. The Service Provider must continuously negotiate beneficial policy conditions for NEMISA with the insurer.
- 3.1.3. The Service Provider must arrange for the issuing of the necessary policy contracts by the insurer, on behalf of NEMISA, as and when required.
- 3.1.4. The Service Provider must administer and facilitate the claims management process from submission to finalisation and reporting stage.
- 3.1.5. The Service Provider must act in NEMISA's best interest in all dealings with the appointed insurers and prospective underwriters.
- 3.1.6. The Service Provider's employees appointed to work on the NEMISA account must fully understand their obligations under the General Code of Conduct issued in terms of FAIS, and any other guidelines that may be issued by a regulatory body having jurisdiction over the Service Provider.
- 3.1.7. The Service Provider must ensure that any third-party service provider appointed by an insurer and/or underwriter to render a service following the occurrence of an insured event is compliant with the taxation laws of the Republic of South Africa. In particular, ensure that third party service providers who render services following the occurrence of an insured event invoice the Service Provider for the services rendered. The Service Provider shall in turn invoice NEMISA for the services rendered by such third service providers; and attach the invoice of the third-party service providers to its invoice.

3.2. Reporting

- 3.2.1. The following **monthly** reports should be provided:
 - 3.2.1.1. A reconciliation of all claims data and contributions paid pertaining to the risk schemes;
 - 3.2.1.2. Monitoring of data movements in respect of the activities on the short-term insurance portfolio and claims register;
 - 3.2.1.3. A reconciliation of:

- Claims received and registered;
- Outstanding claim documents and the reasons thereof;
- Payments made on claims, including verifying the correctness of the payment calculation by the insurance company;
- Repudiated claims; and
- Measures taken by the service provider through a third-party supplier to address repudiated claims, including progress made on any litigation process in connection with a repudiated claim; and

3.2.1.4. A performance report recording any failures to achieve service levels, the nature and date thereof, the causes of the failures and a summary of steps taken to resolve the failures and avoid them in the future.

3.2.1.5. The following quarterly reports should be provided:

- Updating NEMISA on the current state of the insurance market in terms of general economic realities, solvencies, capacity, profitability, rates and market activity and the possible impact of such matters on the NEMISA renewal strategy and insurance portfolio;
- Updating NEMISA on legal developments within the short-term insurance industry and informing NEMISA on insurance product developments, and the risk mitigation developments in the South African market;
- Ongoing evaluation of uninsured risks and possible options for addressing them;
- Ongoing analysis of loss statistics to identify trends to assist NEMISA in future loss prevention and more effective management of risk; and
- Advising NEMISA regarding any reserve accounts with the insurer(s).

3.3. Meetings

3.3.1. The Service Provider will be required to review the NEMISA short-term insurance portfolio with NEMISA Facilities, Information Technology, Human Resources and Finance departments in a formalised pre-set meeting on a quarterly basis.

3.3.2. The Service Provider will be required to report on the overall progress of the Services and discuss service execution issues i.e. problems, risks, administrative issues etc. at a Service Relationship Review on an annual basis.

3.4. Advice to NEMISA The Service Provider must provide financial advice on the short-term insurance portfolio in the event NEMISA requests such advice and must assist NEMISA with the interpretation of insurance policy documents and matters incidental thereto, including the interpretation of insurance rules and regulations.

4. BIDDERS RESPONSES

Bidders are required to submit their detailed response to the requirements in this paragraph. Refer to the technical evaluation criteria in paragraph 13 below (Technical evaluation).

4.1. References

4.1.1. Bidders must provide written contactable references from five (5) of its own current or recent clients (i.e. not older than 24 months) in similar size to NEMISA to whom the bidder is providing or has provided broker services for short-term insurance. The identified reference should complete **Annexure D** and authenticate it with a company stamp or transfer the information onto their companies' letterhead.

4.2. Insurers and/or underwriters

4.2.1. List the insurers and/or underwriters from whom quotes can be obtained to cover NEMISA in respect of each risk area and demonstrate their relationship with the insurer and/or underwriter.

4.2.2. Describe how the bidder will ensure the best quote / quotations for NEMISA e.g. competitive premiums and minimal exclusions.

4.3. Knowledge Sharing

4.3.1. The Bidder must provide details of how it will ensure that NEMISA stays up-to-date with developments in the market. Any additional value adds to NEMISA in line with the scope should be inclusive of the total bid price.

4.4. Claims Settlement

4.4.1. Provide a sample of a monthly reconciliation report, as per the requirements of this tender.

4.4.2. Provide a sample of quarterly reports, as per the requirements of this tender.

4.5. Risk Management

4.5.1. Outline the bidder's process of identifying and mitigating the risks for NEMISA.

- 4.5.2. Bidders must provide a detailed plan on how they propose to set-up the service delivery capability at the awarding of the contract and the handover of NEMISA's short-term portfolio to a new service provider at the expiration of the contract.

1.1 PRE-QUALIFICATION

Bids received from bidders who have a Level 4 to 8 B-BBEE contributor status or a is a non-compliant contributor, will not be considered for evaluation and will be eliminated from further evaluation.

1.2 COMPLIANCE WITH MINIMUM REQUIREMENTS

1.2.1 All bids duly lodged as specified in the Request for Bid will be examined to determine compliance with bid requirements and conditions. Bids with obvious deviations from the requirements/conditions will be eliminated from further consideration.

1.4.2 The score for functionality shall be calculated as follows:

- Each panel member shall award values for each individual criterion on a score sheet. The value scored for each criterion shall be multiplied with the specified weighting for the relevant criterion to obtain the marks scored for the various criteria. These marks should be added to obtain the total score for functionality.
- The score of each panel member shall be added together and divided by the number of panel members to establish the average score obtained by each individual bidder for functionality.

1.5 DETERMINATION OF SCORE FOR PRESENTATIONS

1.5.1 NEMISA will not call for presentations.
OR

1.5.2 NEMISA has decided/may decide to have compulsory presentations made either by all bidders who have obtained at least **75%** of the marks for functionality, or by the bidders ranked first to a maximum of six, but not less than the three highest scoring bidders, once the price and preference marks have been combined.

1.5.3 Presentations shall only affect the marks awarded for functionality. If NEMISA wishes to use presentations to discriminate between bidders, the evaluation criteria to be affected shall be determined in advance and due allowance made in the mark scheme and indicated in paragraph 1.2.1.

1.5.4 Points determined by the presentation will be awarded to each bidder by each member of the Bid Evaluation Committee and then an average calculated. Such score will be added to the original score for functionality.

1.5.5 A bidder will be disqualified if the combined score for functionality fails to meet the minimum threshold for functionality as per paragraph 1.341.

1.6 ELIMINATION OF PROPOSALS ON GROUNDS OF FUNCTIONALITY

1.6.1 Bids that score less than **75%** of the marks available for functionality will be eliminated from further consideration. Marks will therefore not be awarded for their cost proposals or for preference.

1.7 PRICE AND B-BBEE STATUS LEVEL POINTS

1.7.1 All remaining bids will be evaluated as follows:

1.7.2 The 80/20 preference point system will be applied. Points for price and B-BBEE status level certificate will be awarded in accordance with the stipulations in the Preference Point Claim Form in terms of the Preferential Procurement Regulations, 2017.

1.7.3 If appropriate, implied contract price adjustments will be made to the cost proposals of all remaining bids.

1.7.4 The point scored for the B-BBEE status level certificate for each acceptable bid will now be added to the price point.

1.7.5 The Evaluation Committee may recommend that the contract be awarded to the bidder obtaining the highest aggregate mark as determined by 1.5.4 or to a lower scoring bid on justifiable grounds.

1.8 ADJUDICATION OF BID

1.8.1 The relevant award structure will consider the recommendations and make the final award. The successful bidder will usually be the service provider scoring the highest number of points or it may be a lower scoring bid on justifiable grounds or no award at all.
